

## **REGULATION APPLICABLE INSIDE THE MUNICIPAL CAMPSITE, RUE DU PONT DES FEES in BAUGE EN ANJOU**

### **ARRETE**

Wishing you welcome and in the common interest, everyone should respect the following regulation. You have to read it fully before contacting the person in charge of the campsite to show him necessary pieces for the registration. It is only after the registration campers will be able to select their pitch in line with indications of the person in charge.

#### **ARTICLE 1 – ADMISSION CONDITION**

To be admitted to enter, pitch and stay in the campsite, you have to be authorized by the person in charge at the reception desk who always can, for organizational, security, no service reasons, refuse the campsite access.

Campsite access is forbidden to double axletree trailers, campervans or 4 wheel drives.

The person in charge can refuse the access to any vehicle in reason of its size or of its number because they could damage the campsite or around it or its installations.

Access can be refused in reason of the campsite capacity limit.

The person in charge can refuse the access to anybody who could have a behavior annoying for the calm and peace in the campsite.

The campsite access is also forbidden to any drunk person.

The fact to stay inside the BAUGE campsite implies the acceptation of this regulation and to compliment with them.

#### **ARTICLE 2 – POLICE FORMALITIES**

Any person that should stay at least one night in the campsite should first present to the person in charge at the reception desk its ID and fill the police formalities.

Less than 18 years without their parents will be admitted if they have a written authorization from them.

Applying the article of the entry code and of staying for foreigners and the asylum right, the person in charge has to fill and firm by the foreigner client, as he arrives, an individual police paper with:

- Name and first name
- Date and place of birth
- Nationality
- Place of residence

People of less than 15 years old could be mentioned on the same paper as their parents.

#### **ARTICLE 3 – INSTALLATION**

Tent, trailer and motor home and material coming with must be put on the pitch designated and in line with the different rules given by the person in charge.

The person in charge can, depending on service or organization need, ask during your stay, to move your tent, your vehicle or trailer.

For the chalets, bivouacs and pitches, you must leave before 10am and you can arrive from 3pm.

#### **ARTICLE 4 – WELCOME DESK - OPENING**

Each year, opening and closing dates of the campsite as well as the opening schedule are displayed at reception and on the website of the campsite.

You can find at the reception desk all the information on the campsite services, the shops, the sport complex, the touristic attractions and many directions close by which can be useful.

A satisfaction form is available for all clients.

## **ARTICLE 5 – FEES**

Fees are payed at the reception desk. Their amount is fixed following the prices voted by the municipality. They are due depending on the number of nights you stay at the campsite and the services consumed.

The campsite users are invited to give their departure date one day in advance.

A deposit will be asked for any chalet/bivouac renting or campsite material lending, under prices voted by the municipality.

For all booking of a pitch, a bivouac or a chalet, 30% pre-payment are asked at the booking. For any stay cancelation, the prepayment will be kept.

### Pitches :

Full payment of the fees must be done, the day before leaving.

### Chalets et bivouacs :

The full payment must be done one month before your arrival date excepted if you book the same day.

For any stay cancelation, the full payment will be kept except for specific cases (death, disease, ...) with official justification.

The stay payment can be done by credit or debit card, money transfer, chèques, cheques vacances or cash.

The campsite user must pay the touristic tax, at maximum, the day before leaving.

## **ARTICLE 6 – NOISE AND SILENCE**

The campsite users as well as their guests are always asked to avoid noise and chatting that could annoy their neighbor.

The noisy apparels must be tuned in consequences. Closing doors and bunks must be as discrete as possible.

Silence must be total between 10pm and 7am. From 10pm to 7am, noisy activities, singing and calling are forbidden.

Excessive alcohol consumption as well as narcotic product inside the campsite or closely, is an infraction at the present rule and could result in the direct cancelation of the renting contract.

## **ARTICLE 7 – PETS**

Dogs and cats must never be without a leash. They must not be let in the campsite, even inside, without their owner who are responsible for them.

Pets have to be vaccinated and their vaccination proof must be asked by the person in charge.

Only dogs and cats are tolerated, with a supplement, in the chalet. No other animal will be authorized.

## **ARTICLE 8 – GUEST**

As they arrive in the campsite, guests must show them to the person in charge to get his agreement.

After being authorized by the person in charge from the reception desk, guesses can be admitted in the campsite under the campers who guess them responsibility.

guess cars or any other vehicles are forbidden in the campsite.

### **ARTICLE 9 – VEHICLES CIRCULATION AND PARKING**

Inside the campsite, vehicles must drive at a speed limited to 10km/h.

Circulation is forbidden between 10pm and 7am.

Only the camper vehicles can drive inside the campsite.

Parking, strictly forbidden on the pitch usually occupied by camping stuff, must not, block the circulation neither the new coming installation.

### **ARTICLE 10 – DRESS CODE**

Correct clothes are mandatory (swimming wear authorized).

No word, song or behavior must disturb the neighbors in particular children.

Une tenue correcte est exigée (maillot de bain autorisé).

All politic or religious meeting, any commercial advances are strictly forbidden inside the campsite.

Nobody can stay in the campsite if they are under a contagious disease (coqueluche, etc).

### **ARTICLE 11 – WELL BEING AND INSTALLATION RESPECT**

Each one has to behave such that he does not degrade the cleaning, the hygiene and the site of the campsite.

It is forbidden to throw grey water on the ground or in the canalization.

People using trailers and motor home must throw their grey water in the installation specically done for this.

Garbage, waste and paper must be put in the recycling area and in the containers done for this.

Sanitary area has to be held in a constant good well being by the users.

The cleaning is strictly forbidden outside of the area done for this.

Trees and flowers decoration must be respected. It is forbidden for the campers to put nail in the trees, to cut branch and to plant anything.

Neither it is allowed to put limit of an installation in the pitch by personal means neither to dig in the ground.

The pitch which has been used during the stay must be put back in its initial state.

### **ARTICLE 12 – SECURITY**

#### a) Fire.

Open fires (wood, coil, ...) are strictly forbiden.

BBQ are authorized.

Camping stove must be held in a perfect functioning state and cannot be used in dangerous conditions.

Fire extinguishers are used in necessity cases. In case of fire, call the firemen and contact immediately the person in charge.

A first aid kit is available at the reception desk.

Even if trailer keeping service is available, campsite users are invited to take the usual precaution to keep their material safe.

#### b) Robbery

The person in charge is not responsible for object put at the reception desk and has a general obligation to keep a close watch on the campsite. For these objects put at the reception, campers must inform the person in charge of their values. The person in charge can refuse to keep them.

Campers keep the responsability of their own installation and of the object put in its private installation or in the comunal space.

Give a call to the person in charge if you suspect anybody in the campsite.

### **ARTICLE 13 – GAME**

No violent or disturbing game can be organised closed to the installations.  
Kids must always be under the watch of their parents.

### **ARTICLE 14 – STORAGE OPTION**

You can only let unoccupied material on the campsite after the direction agreement and only on the given pitch. The person in charge is not responsible of the material when the owner is not here. A fee which the amount is displayed at the reception desk, will be due for the storage option.

### **ARTICLE 15 – DISPLAYING**

The actual regulation is displayed at the campsite entry.  
It can be given to the client on their asking.  
The campsite ranking displaying is displayed at the campsite entry.  
Prices of each service is communicated to the clients in the fixed conditions by the Municipality choices.

### **ARTICLE 16 – IMAGE RIGHTS**

The campsite is authorized to use pictures taken during your stay, on any support, for the advertising campsite need without any counterparts.  
On a simple request to our direction, your image won't be used.

### **ARTICLE 17 IT AND RIGHTS**

Infomrations given at the booking time are confidential and will not be given to a third party.  
In line with IT law and rights, each camper has the right to access, modification and opposition to the personal data. For this, it needs to give us a writing asking.

### **ARTICLE 18 – VIOLATION OF THE REGULATION**

In the case of a resident disturbing the other users stay or not respecting the articles of this regulation, the person in charge or its representant could by voice or writing, if he finds it necessary, put an undertaking on the resident to stop its disturbing.  
In case of serious regulation violation after undertaking by the person in charge for respect it, he could cancel the contract without any indemnities, neither refund.  
In case of penal infraction, the person in charge could call the law representant.
